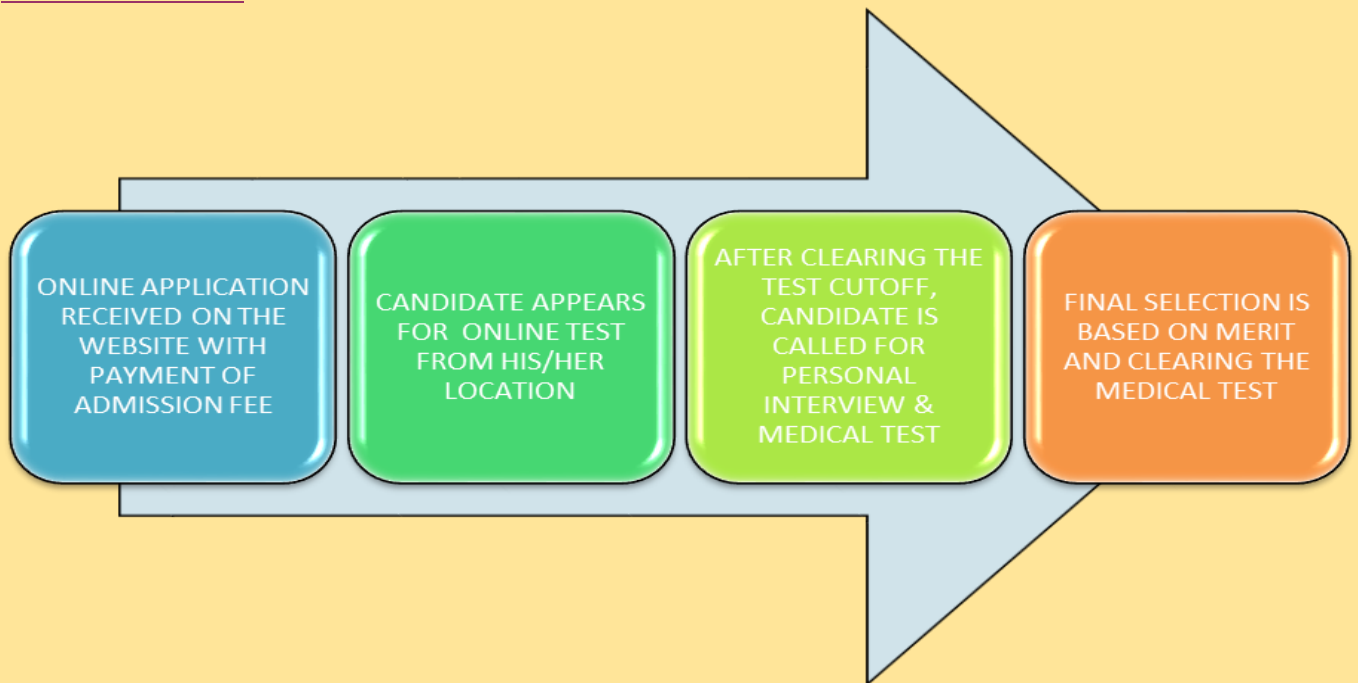
Eyesight:

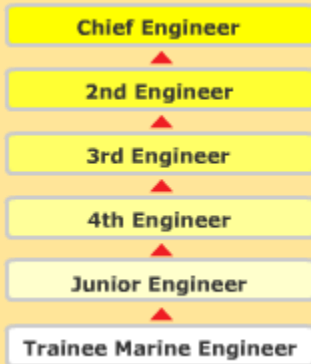
