4. There is no CET to be conducted by the Govt. or the Board of Examination for Seafarers.
5. An In-house Test/Personal Interview will be conducted by a Team of GES.
6. A Exit Examination will be conducted by the Board of Examination for Seafarers on completion of 6 months Pre-Sea Course in our Institute at Lonavala. On Passing this Examination, a Course Completion Certificate will be issued by The Great Eastern Institute of Maritime Studies (GEIMS).
7. Indian CDC will be obtained by GEIMS from the office of Shipping Master/DG Shipping.
8. On receipt of CDC, candidate’s joining will be planned within 2 to 6 months’ time on board the vessels owned by GES/GIL.
9. Candidates will be placed on board on our vessels in the respective Trained Trade (Category) (Deck/Engine/Saloon) for 9 months as a Trainee Seamen/Trainee ERR/Trainee Cook respectively.
10. During this period of Training of 9 months, an amount of Rs.10,000/- per month towards stipend will be paid.
11. The 2nd Contract of 9 months will be given as per Company rules & regulation and will be paid according to company scale in force.
