Sub: Common Entrance Test June 2018- for admissions to various programmes of IMU - reg.

1. Admissions to various Programmes conducted in IMU Campuses and Affiliated Institutes are done through an All-India Common Entrance Test (CET). This Common Entrance test (CET) for admissions to various programmes for the Academic Year 2018-19 will be done online mode.
2. The advertisement for online CET for admissions to all UG and PG courses offered by IMU and its Affiliated Institutes for **August 2018** batch will be published on 06-04-2018 in leading newspapers in Hindi , English.
3. The entire spectrum of activities –from the registration of applications to the publication of results is being done online by M/s National Stock Exchange – IT the Service Provider. This year's CET will be held **between 11.00 am and 2.00 pm on Saturday, 02<sup>nd</sup> June 2018 in 36 cities all over India.**
4. The Online registration for the Candidates to register and pay the fees will be open from **06-04-2018**. The last date for the online registration of applications is **11-05-2018**. To supplement this effort, Principals of Affiliated Institutes are requested to give wide publicity through social media, schools and coaching institutes so that the maximum number of candidates apply for the CET June 2018. The Time Line for CET is given below:

4. Kind attention of all affiliated Institutes is drawn to Section 5, sub-sections (xxvii) and (xxxiii) of the Indian Maritime University Act, 2008 read with Chapter VII of Ordinances Governing Academic Matters as published in the Gazette of India Extraordinary on 12<sup>th</sup> May 2009 according to which no student shall be eligible for admission to any UG or PG course in the IMU unless he has passed the exam or exams prescribed by the University. Passing the CET conducted by the IMU is one of the essential eligibility criteria for admission, along with criteria relating to age, marks in plus 2 exams, medical fitness, etc., No Affiliated Institute shall therefore, make any admissions of students (including sponsored/management candidates) unless they have qualified in the CET June 2018. It may be noted that if any candidate is admitted without qualifying in CET June 2018, he will not be given admission registration number nor will he be allowed to appear in any of the scheduled examinations of IMU.
